Set-up starts at noon on September 15, 2022. Mandatory cooks' meeting at 7:00pm on September 16, 2022.

We will once again have two fajita categories - traditional and gourmet and three specialty categories - pan de campo, frijoles a la charra & beef mollejas competition. There will be cash prizes and best of all those great miniature BBQ pit trophies for first place!

We will have live entertainment, kiddie carnival with mechanical rides, bouncers, and inflatables as well as some of the fiercest cooking competition north of the Rio Grande River. All in all, this is turning out to be one of the best Cookoffs ever. Don't miss out!

RULES & REGULATIONS

- Contest is limited to the first 50 entries and are subject to team qualifications. Entry deadline is 5:00p.m., Thursday, September 15, 2022. Contestant set-up will be from noon to 7pm on Friday, September 16, 2022.
- No Vehicles are allowed in primary Cooking Camps. Plenty of parking will be available in designated Cookoff contestant parking.
- Cooks' meeting will be held on Friday at 7:00pm.
ATTENDANCE IS MANDATORY.
- Contest starts at 11am on Saturday, September 17.
Judging/turn-in times will start at the following times:
 - * Pan de Campo - 1:00pm
 - * Frijoles a la Charra - 2:00pm
 - * Beef Mollejas/Sweetbreads - 3:00pm
 - * Traditional Fajitas - 4:00pm
 - * Gourmet Fajitas - 5:00pm
- Pan de Campo must be cooked in a DUTCH OVEN OVER COALS, NO GAS. Prior mixing of dough is allowed. Actual cooking must be done on location.
- Frijoles a la Charra must be cooked/prepared on location. You may cut or chop you ingredients in advanced. Propane allowed.
- Mollejas/Sweetbreads must be cooked/prepared on location. Beef mollejas/sweetbreads ONLY. Propane allowed.
- No open fires or ground pits are allowed. All teams must provide a fire extinguisher.
- All team entries will be judged for showmanship with no additional fees required.
- Mechanical tenderizing is **NOT** allowed. Prior marinating is allowed but no commercial marinating. Actual cooking must be done location.
- If your sponsored cooking team wins, the winning check will be given to the sponsor.
- NO MEAT OTHER THAN BEEF SKIRTS MAY BE USED** for the Fajita competitions. (No sirloin)
- Written recipes and serving instructions must be provided at check-in time for **gourmet entries**. Each contestant must display all ingredients to Cookoff officials prior to cooking on Saturday.
- Judging categories and criteria:
 - A. Traditional - Taste and tenderness
 - B. Gourmet - Taste, tenderness, appearance & recipe originality
 - C. Pan de Campo - Appearance, softness and taste
 - D. Mollejas/Sweetbreads - Texture and Taste
 - E. Frijoles a la Charra - Aroma, Color, Texture, Overall Taste
 - F. Showmanship - Originality of display area and team that puts on the best show.
- Camp Area - Includes up to 5 people on the team (including cook) and a 20'x20' or larger space for camp and cooking rig.
- Cookoff contestants must provide meat, barbecue pit, utensils, supplies etc.

WAIVER OF LIABILITY AND HOLD HARMLESS AGREEMENT

1. In consideration for receiving permission to participate in the **Fajita Cookoff 2022 - South Padre Island** (hereinafter referred to as "Cookoff"), on **September 17, 2022** I hereby release, waive, discharge and covenant not to sue **The Fajita Cookoff**, its officers, servants, agents and employees (hereinafter referred to as "releasees") from any and all liability, claims, demands, actions and causes of action whatsoever arising out of or relating to any loss, damage or injury, including death, that may be sustained by me, or to any property belonging to me, whether caused by the negligence of the releasees, or otherwise, while participating in the **Cookoff**, or while in, on or upon the premises where the **Cookoff** is being conducted, while in transit to or from the premises, or in any place or places connected with the **Cookoff**.
2. I am fully aware of risks and hazards connected with being on the premises and participating in the **Cookoff**, and I am fully aware that there may be risks and hazards unknown to me connected with being on the premises and participating in the **Cookoff**, and I hereby elect to voluntarily participate in the **Cookoff**, to enter upon the above named premises and engage in activities knowing that conditions may be hazardous, or may become hazardous or dangerous to me and my property. I voluntarily assume full responsibility for any risks of loss, property damage or personal injury, including death, that may be sustained by me, or any loss or damage to property owned by me, as a result of my being a participant in the **Cookoff**, whether caused by the negligence of releasees or otherwise.
3. I further hereby agree to indemnify and save and hold harmless the releasees and each of them, from any loss, liability, damage or costs they may incur due to my participation in the **Cookoff**, whether caused by the negligence of any or all of the releasees, or otherwise.
4. It is my express intent that this Release shall bind the members of my family and spouse, if I am alive, and my heirs, assigns and personal representative, if I am deceased, and shall be deemed as a Release, Waiver, Discharge and Covenant Not to Sue the above named releasees. In signing this release, I acknowledge and represent that:
 - A. I have read the foregoing release, understand it, and sign it voluntarily as my own free act and deed;
 - B. No oral representation, statements or inducements, apart from the foregoing written agreement, have been made;
 - C. I am at least eighteen (18) years of age and fully competent; and
 - D. I execute this Release for full, adequate and complete consideration fully intending to be bound by same.
