 - Non-Artisan/Craft items must be **genuine products** in accordance with all patent & trademark laws. Non-complying vendors will be asked to remove such product or may be asked to leave WITHOUT a refund.

TERMS & IMPORTANT NOTICES: Arts in the Park fees are due, in full, prior to October 13, 2017. Vendor agrees that this document, when signed below constitutes a binding agreement. Vendor further agrees that upon The Fajita Cookoff receipt of this signed agreement, it shall be enforceable in accordance with its terms. By signing below, the individual represents and warrants that he/she is duly authorized to execute this binding agreement on behalf of Vendor.
